Dear Citizens:

The Historic Rivers Chapter (HRC) of the Virginia Master Naturalist Program (VMN) is accepting applications for its Cohort XI Basic Training Program, which will begin Tuesday, September 6, 2016, and end March 8, 2017.

Most training classes will be held on Tuesday nights, 6 – 9 p.m. at the James City County Police Department's Law Enforcement Center on 4600 Opportunity Way, Williamsburg, 23188, and during the day on occasional weekends at various locations. Field trips are also held during the day on weekends at various locations. See the schedule on page 5.

Note: Dates are subject to change.

The Virginia Master Naturalist Program is a statewide corps of volunteers who provide education, outreach, and service dedicated to the beneficial management of natural resources and natural areas within their communities. Interested Virginians become Master Naturalists through training, continuing education, and volunteer service.

People who are curious about nature, enjoy the outdoors, and want to be a part of natural resource management and conservation in Virginia are perfect candidates to become Virginia Master Naturalists.

The process for becoming a certified Virginia Master Naturalist typically takes 6 to 12 months. To become a member of the HRC, one must enroll in the basic training course.

Virginia Master Naturalists achieve certification by:

- Completing Basic Training
- Completing an additional 8 hours of Continuing Education
- Completing 40 hours of Volunteer Service

Enrollment in Basic Training is limited to 20 applicants. Applicants will be accepted on a first-come, first-served basis. Tuition, which includes all materials and instruction, is \$175. The annual HRC membership dues will be an additional \$25 and can be paid between January 1 and March 8, 2017.

Historic Rivers Chapter Basic Training Requirements:

- 1. The expectation is that you will <u>attend</u> every class and field trip. Still, "life happens." In order to successfully complete and graduate Basic Training, you may miss no more than two classes and no more than one field trip. See individual dates below; please keep in mind that dates may change.
- Attend a minimum of two hours on at least one bird walk or Bird Club field trip with either the
 Williamsburg Bird Club or the Hampton Roads Bird Club. You will receive information about these
 opportunities early in the program. All subsequent hours spent on bird walks and Bird Club field trips
 will count toward continuing education.
- 3. Attend a minimum of two hours on at least one native plant walk with a chapter of the Virginia Native Plant Society. The local John Clayton Chapter leads 1 2 walks per month (sometimes more) in the fall. You will receive information about these opportunities early in the program. All subsequent hours spent on native plant walks will count toward continuing education.
- 4. Attend at least one program, **in person**, in the series "VIMS After Hours" presented the last Thursday of most months at VIMS in Gloucester Point, VA. You will receive information about these opportunities early in the program. All subsequent hours spent attending "VIMS After Hours" programs will count toward continuing education.
- 5. <u>Attend</u> at least one meeting of the Historic Rivers Chapter Board, which meets at 6:30 pm on the first Wednesday of each month. Location is to be determined. All subsequent hours spent attending Board Meetings will count toward volunteer service.
- 6. <u>Research/Develop/Present</u> as a group, a biography of a noted naturalist/scientist. You will receive information about this requirement early in the program.
- 7. A Class Topic Exploration Activity (CTE), distributed by email, may follow each class session. You must complete and return the CTE by the due date. These CTEs are reviewed but are not graded.
- 8. An open book/notes final exam will be distributed by email during the last several weeks of the program. You <u>must achieve 70% or better</u> on the final exam in order to successfully complete and graduate Basic Training.

Most training classes will be held Tuesday nights, 6 – 9 p.m. at the James City County Police Department's Law Enforcement Center on 4600 Opportunity Way, in Williamsburg, and on occasional weekends. Field trips are also held on occasional weekends. See schedule on page 5.

Note: Dates are subject to change.

Unless otherwise noted, evening classes begin promptly at 6:00 p.m. and end at or before 9:00 p.m. The 2016-2017 specific training dates are below. Dates are subject to change.

Note: One class in September 2016 and three classes in February 2017 will be held on a Saturday. <u>These</u> are considered classes and not field trips.

The Virginia Master Naturalist Program is a statewide corps of volunteers who provide education, outreach, and service dedicated to the beneficial management of natural resources and natural areas within their communities. Interested Virginians become Master Naturalists by participating in Basic Training, continuing education, and volunteer service.

The program is composed of 29 semi-independent, locally focused chapters that are supported, guided, and represented by the over-arching statewide VMN program. It is sponsored jointly by Virginia Cooperative Extension, the Virginia Department of Conservation and Recreation, the Virginia Department of Environmental Quality, the Virginia Department of Forestry, the Virginia Department of Game and Inland Fisheries, the Virginia Institute of Marine Science's Center for Coastal Resources Management, and the Virginia Museum of Natural History. Virginia Master Naturalist volunteers engage in a variety of service projects in their local communities. These projects focus on one or more of four key areas: citizen science, stewardship, education/outreach, and chapter administration.

Citizen Science projects can involve bird, butterfly, frog and toad counts as well as collection of environmental data. Volunteers use protocols to collect the information that scientists and natural resource managers need to study the lives, habits, and responsiveness to change of plant and animal species or communities.

Stewardship projects may include planting trees, protecting streams, and building or maintaining park trails. Stewardship projects involve restoring and maintaining wildlife habitat and improving water quality.

Education/Outreach projects involve providing environmental education to adults as well as children. This may involve working with school groups or leading programs in nearby parks.

Volunteers who desire a leadership role in the chapter are encouraged to become involved in **Chapter Administration**. Chapter Administration can include volunteer management, project management, and overall chapter management.

The Historic Rivers Chapter (HRC) of the Virginia Master Naturalist Program is based in Williamsburg and James City and York Counties and is currently reviewing applicants for its Basic Training program. Applicants are asked to complete a registration application and to provide three personal references. Personal references are an essential element of the application package. They help to ensure the success of each potential volunteer and the safety of all citizens participating in our program and projects.
